Bid documents will be available from **September 28 – October 6, 2022** from **9:00 AM – 4:00 PM** (except Saturdays, Sundays & Holidays), at the PhilHealth BAC-Disposal Committee Secretariat, Room 202 Management Services Division, PhilHealth Regional Office XI, Valgosons Building, Bolton Extension, Davao City. **VIEWING/INSPECTION** for the said waste materials will be conducted on **SEPTEMBER 28 - October 5, 2022** at DDIS Warehouse, Diversion Road, Brgy. Matina Pangi, Davao City. Only those who obtain bid documents may view/inspect the equipment.
