Delivery of the Goods is required by **December 7**, 2022 to **December 31**, 2022. Bidders should have completed, within **two(2) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

 Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183

- Prospective Bidders may obtain further information from PhilHealth Regional Office II and inspect the Bidding Documents at the address given below during office hours from 8:00AM to 5:00PM.

A complete set of Bidding Documents may be acquired by interested Bidders on November 9, 2022 to November 29, 2022 @ 9:30AM from the given address and website below and upon payment of a non-refundable fee of One Thousand Pesos(Php1,000.00). The Procuring Entity shall allow the bidder to present its proof of payment for the fees through email indicated below.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay pay the applicable fee for the Bidding Documents not later than the submission of their bids.
