

This Contract is made and entered into by and between:

BRUSHWORKS ADVERTISING, a juridical entity duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with principal office address at P-1, Peñaranda St., Bonot, Legazpi City represented herein by its manager/owner ARTURO T. MENDOZA, hereinafter referred to as "BRUSHWORKS ADVERTISING";

-and-

PHILHEALTH REGIONAL OFFICE V, a government owned and controlled corporation duly registered, organized and existing under Philippine laws with principal office at ANST Bldg. IV, Benny S. Imperial St., Legazpi City, represented herein by its Regional Vice-President, ALBERTO C. MANDURIAO herein referred to as "PHILHEALTH"

#### -WITNESSETH-

WHEREAS, PHILHEALTH desired to engage the services of a competent qualified and able tarpaulin printing service company for PROV;

WHEREAS, BRUSHWORKS ADVERTISING, a duly registered and licensed business entity offered to render the required tarpaulin printing service and offered the lowest quotation.

**NOW, THEREFORE,** for and in consideration of the foregoing premises, the parties hereto agree under the following terns and condition, to wit:

### I. DUTIES AND RESPONSIBILITIES OF BRUSHWORKS ADVERTISING

To provide tarpaulin printing services, particularly described hereunder, to PhilHealth Regional Office V:

- a. Printing of full color tarpaulin (Blackout), at least 18 ounces in thickness, with or without eyelet;
- b. Fast turn-around time and can deliver printed materials to PhilHealth Regional Office V within three (3) calendar days upon the receipt of the request;
- c. BRUSHWORKS ADVERTISING has the option to suspend the delivery of items and/or services if PHILHEALTH fails to pay any outstanding charges beyond 15-day payment period of the following month

#### II. DUTIES AND RESPONSIBILITIES OF PHILHEALTH

To pay BRUSHWORKS ADVERTISING an amount based on the table provided below:

The above-mentioned price shall be inclusive of all government required fees and taxes, to be paid by PhilHealth less applicable taxes upon presentation of a billing statement or notice payment.

#### III. GENERAL PROVISIONS

- 1. BRUSHWORKS ADVERTISING should provide consistent quality, prompt and accurate tarpaulin printing
- 2. Only official requests for tarpaulin printing emanating from PHILHEALTH PROV Public Affairs Unit shall be recognized by BRUSHWORKS ADVERTISING.

#### IV. PERIOD OF CONTRACT

This contract shall commence on February 11 to December 31, 2025 subject to renewal as may be agreed upon by the parties

This contract shall take effect on the above period, unless sooner terminated in accordance the provision hereof. **PHILHEALTH** reserves the right to pre-terminate the contract after giving (10) calendar days advance written notice to the other party after due verification of facts that **BRUSHWORKS ADVERTISING** is not providing satisfactory good or not complying with the terms and conditions of the contract.

#### V. BREACH OF CONTRACT

Violation of any of the provisions of this contract shall give the aggrieved party the right to rescind this contract, without prejudice to such other available remedies as provided by law. However, the parties shall first exert their best efforts to amicably settle their differences before seeking judicial relief.

#### VI. TERMINATION OF CONTRACT AND VENUE OF ACTION

PHILHEALTH or BRUSHWORKS ADVERTISING reserves the right to preterminate this Contract, if any of the provision/s under this Contact is violated by one (1) or both parties provided that a prior written notice is served to the party at least 10 days in advance. In case of litigation arising from or in connection with this Contract, the parties agree that the venue of any action shall be at the proper court in Legazpi City, to the exclusion of all other courts.

#### VII. MISCELLANEOUS PROVISIONS

In case any provisions or stipulation hereof are declared invalid, null and void or contrary to law, rules and regulations by a court of competent jurisdiction, the unaffected provisions or stipulations thereof shall remain valid and effective

Lastly, BRUSHWORKS ADVERTISING shall shoulder the cost for the notarization of the herein CONTRACT OF SERVICE subject to furnishing PHILHEALTH four (4) duplicateoriginal copies of the notarized contract.

#### NO GIFT POLICY PROVISION VIII.

No PhilHealth personnel shall solicit, demand or accept, directly or indirectly, any gift forms, any person group, association or juridical entity, whether from public or private sector, at any time on or off the work premises where such gift is given the course of official duties or in connection with any transaction which may affect the functions of their office or influence the actions of directors and employees or create the appearance of conflict of interest.
