All interested parties are invited for the **PRE-BID CONFERENCE** at the Philhealth Regional Office XI Conference Room, 2<sup>nd</sup> Floor Valgosons Building, Bolton Extension, Davao City **MAY** 13, 2025 at 1:30 P.M.

The bid documents shall be available at Room 202 Management Services Division, Valgosons Building, through MR. GARY E. SAMONTE, PRO XI BAC Secretariat, starting MAY 2, 2025 to MAY 23, 2024, from 8:00 AM to 5:00 PM and MAY 26, 2025 from 8:00 AM to 10:00 AM, upon payment of non-refundable fee of the bidding documents in the abovementioned table schedule.

The bidders shall drop their duly accomplished bid documents namely: (1) eligibility requirements and technical proposal and (2) financial proposal in two separate sealed envelopes in the bid boxes located at PHILHEALTH REGIONAL OFFICE XI, ROOM 202 2<sup>nd</sup> FLOOR VALGOSONS BUILDING, BOLTON EXTENSION, DAVAO CITY. Deadline for submission and receipt of bids shall be on MAY 26, 2025 UNTIL 10:00 AM.

The official time clock shall be the Automated Daily Time Management (ADTMS) located at the 2<sup>nd</sup> Floor of Valgosons Building, Bolton Extension, Davao City. Any bid submitted after the cut-off time will not be accepted. OPENING OF BIDS SHALL BE ON MAY 26, 2025 at 3:00 PM. Any bidder who comes late will not be entertained.

The BAC shall determine if each prospective bidder is eligible to participate in the bidding by examining the completeness of each prospective bidder's eligibility requirements or statements against a checklist of requirements, using the **NON-DISCRETIONARY "PASS/FAIL" CRITERIA.** 



The acceptable forms of bid security that bidders may opt to use, which include the **NOTARIZED BID SECURING DECLARATION** or at **LEAST ONE** (1) **OTHER FORM**, the amount of which shall be equal to a percentage of the ABC in accordance with the following schedule:
