**BAC RESOLUTION RECOMMENDING THE APPROVAL OF THE AWARD  
OF CONTRACT FOR THE PROCUREMENT OF 1 LOT LEASE OF VENUE  
WITH MEALS FOR THE CONDUCT OF CY 2025 HEALTHCARE  
SERVICES ENGAGEMENT FORUM OF LHIO BACOLOD THROUGH  
NEGOTIATED PROCUREMENT- LEASE OF REAL PROPERTY AND  
VENUE**

**WHEREAS**, on May 14, 2025, the BAC, thru its Secretariat, received the Purchase Request (PR) No. 0237-2025 with an Approved Budget for the Contract (ABC) of Seventy-Two Thousand Two Hundred Fifty Pesos (P 72,750.00) for the procurement of 1 Lot Lease of Venue with Meals for the Conduct of CY 2025 Healthcare Services Engagement Forum of LHIO Bacolod through Negotiated Procurement- Lease of Real Property and Venue;

**WHEREAS**, attached to the PR are the following: (1) Annual Procurement Plan (APP); (2) Approved Terms of Reference; (3) Abstract of Market Survey with three (3) Request for Market Survey; and, (4) Approved Budget for the Contract (ABC);

**WHEREAS**, Section 53.10 of the IRR of RA 9184 allows Negotiated Procurement in cases of Lease of Venue for the procurement covering Lease of Real Property and Venue for official use which *may include Meals and Accommodation depending on the requirements of the Procuring Entity as prescribed in Annex "H" of this IRR*;

**WHEREAS**, three (3) suppliers responded to the Request for Quotation namely: (1) SM Prime Holdings, Inc. (Park Inn by Radisson Bacolod); (2) RFC Metro Inn; and, (3) Hometown Hotel Bacolod;

**WHEREAS**, the offer of **SM PRIME HOLDINGS, INC. (PARK INN BY RADISSON BACOLOD)** was found to be compliant with the Terms of Reference, declared as Single Calculated Responsive Bidder per End-user's recommendation, and received a 99.75% Factor Value according to Table of Rating Factors for Lease of Venue;

**WHEREAS**, the winning bidder was able to comply with the submission of mandatory requirements such as valid Business Permit, PhilGEPS Registration (Platinum Membership valid until October 29, 2025), CY 2023 Annual Income Tax Return and Certificate of Good Payment Standing (CGPS) covering the period April 2024 to March 2025 as proof of latest PhilHealth Contribution;

**WHEREAS**, the BAC found the Recommendation of Admin-GSU to be with merit, thus unanimously ruling to accept said recommendation.



**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:
